- b. Report of budget to actuals was provided by Alicia Ekland. Current Year Budget \$9,813.00; Current Year Actual \$4,747.81; Percentage of Budgeted Revenues Collected 48.38%; and Current Year Expenditures \$3,555.00. Currently, the Law Library has \$1,173.79 to spend as of 12/31/2017. Alicia Ekland reported the Law Library received \$700.00 in revenue, reduction of revenue is due to the reduction of the number of filings, court fees collected.
