EMS and LEMSA:

John Lord, SSV – John gave an update on the CARR Fire. There will be a Hot Wash for affected agencies on October 15, 2018 at the Red Bluff Community Center. Additional education and training and streamline of resource requesting for medical and health.

The next Medical Control Committee is 9/18/18. There is an Air Ambulance Committee meeting in November – they will be updating the Aircraft Resource Guide.

Lori Finch, Westside Ambulance – Lori stated that Westside is overwhelmed and requested that the Ambulance Task Force be reinstated to explore options for obtaining more ambulance service in Glenn County.

Wayne Samson, Enloe EMS – Staffing continues to be an issue.

OES/Law:

J.C. Tolle – Nothing to report.

Amy Travis -

- Amy deployed to the Carr and Klamathon Fires under mutual aid. The Mendocino Complex affected Glenn County directly and the local emergency proclamation is still in effect, but will be terminated soon. Public information used during the fire was Code Red, Nixle, Social Media, and standard press releases. She encouraged everyone to sign up for Code Red as this will be the system used for evacuation notices.
- CodeRED emergency alert drill scheduled for 9/17/18
- FEMA will be holding an iPAWS (Integrated Public Alert and Warning System) drill on 9/20/18 at 1100.
- There was a Hazmat incident in Elk Creek. Issues arose with mutual aid request procedure for hazmat team. OES will work with LEPC to identify what is the best way for Glenn to request and receive a Hazmat team for future incidents.
- PG&E has awarded a \$20,000 grant for a disaster response trailer for the county Amy will talk with fire chiefs, etc. to determine the best use of these funds and where a trailer might be located, etc.
- There is an executed agreement with the Glenn County Fairgrounds for sheltering needs it will be a fee for service and there is a breakdown of costs for every building, etc.
- There is an executed agreement with OUSD for sheltering/showering needs and WUSD is open to a similar agreement, so that should be in place soon.

Fire:

OVFD – John McDermott – Their repeater is getting fixed, it will be more powerful. There is a new tax/assessment on the November ballot for rural fire department. They are looking to hire a paid fire chief – the position will be paid 50/50 City/Rural to start with.

Hamilton City Fire – Dan James –Thanked WWA for coming up on the radio when responding to HC calls. Requested Butte EMS and Enloe do the same. They are still having dispatch problems/issues.

Willows – Wayne Peabody – WFD deployed to the Carr Fire for 24 days. They are working with OPD and GCSO on an active shooter exercise in the south county, scheduled for February 2019. They continue to work on their communications issues.

HHSA:

Laura Medina – PH is holding several flu clinics in September/October and has several upcoming exercises, including setting up the mobile field hospital, Mass Vaccination, and the SWMHE on infectious disease.

Healthcare Facilities:

Glenn Medical Center-

Not present

NVIH-

Tracie Ellis - they will be hosting a health fair on 9/21/18.

Willows Care-

Not present.

Home Health -

Not present.

Far Northern Regional -

Michelle reported they lost one care home in the Carr Fire that had housed 6 clients. They have been relocated. They were able to successfully evacuate all their clients. One staff member lost their home.

CUPA/Air Pollution Control:

Eric reported that fall rice burns are starting. Their Twitter account will have daily burn status. There was a wildfire symposium in Sacramento that was based mostly on after action items like ash and debris removal.

Community-based Organizations :

Phil Zabell –. They are getting the solar panels on their disaster response trailer. ARES has been reactivated in the county with Mike Maddalena (Kanawha Fire) as the EC. They want to build relationships with local fire departments and law enforcement.
