PUBLIC HEALTH OFFERS WEEKLY CLINICS IN 2023

Glenn County, CA - Glenn County Public Health will be hosting twice weekly clinics offering TB testing, pregnancy testing, the seasonal influenza vaccine, and Bivalent COVID-19 booster vaccine. Clinics will be offered in Willows the first and third week of the month, and in Orland the second and fourth week of the month. Willows- 1st and 3rd Week of the Month:

Public Health Office- 240 N. Villa Ave. Willows

TB Testing: only on Tuesdays 9:00 am – 1:00 pm

Pregnancy Testing: Tuesdays and Thursdays, 9:00 am – 1:00 pm

Seasonal Influenza and Covid-19 Boosters: Tuesdays and Thursdays, 9:00 am – 1:00 pm

Orland- 2nd and 4th Week of the Month:

WIC Office- 127 E Walker St. Orland

TB Testing: only on Tuesdays 9:00 am – 1:00 pm

Pregnancy Testing: Tuesdays and Thursdays, 9:00 am – 1:00 pm

Seasonal Influenza and Covid-19 Boosters: Tuesdays and Thursdays, 9:00 am – 1:00 pm

TB testing will be offered with a \$10 administration fee in exact change or check. The influenza vaccine is FREE to all persons 6 months of age and older. The Bivalent COVID-19 booster is FREE to all persons 12 years of age and older at least 2 months after completing their primary COVID-19 vaccine series and/or receiving a prior COVID-19 booster dose. Flu and COVID-19 vaccines may be administered concurrently, so do not hesitate to get boosted against COVID-19 when receiving your flu shot.
