5. REPORTS AND DISCUSSION ITEMS

MATTER 5.1 **LANDFILL OPERATIONS**

Dr. Qureshi reported operations are running smoothly, new Transfer Station complete, and reminding those present of the Open House.

MATTER 5.2 **CLOSURE CONSTRUCTION**

Dr. Qureshi reported lowest bid came in from Stimpel-Wiebelhaus & Associates, Inc. and is currently under review with County Counsel. Chair Barr inquired on the number of responses.

Dr. Qureshi replied ten (10). In addition, we are looking at mid-May for Closure to begin with hopes of completion in the Fall of November 2020, which is deadline from the Water Board.

-Recycling Grants & Programs – Reported by Talia Richardson: <u>Used Oil Payment Program (OPP)</u>

OPP8 – Fiscal Year 2017-18: discontinued County payment of disposal fees for non- Certified Centers. Create new County Certified Center, one pending. Purchased oil filter crusher for Thunderhill Raceway.

OPP9 – Fiscal Year 2018-19: Application awarded twenty thousand dollars (\$20,000.00).

Household Hazardous Waste Discretionary Grants (HHW)

Events will be held in 2020.

Local Government Waste Tire Amnesty Grant

Seven thousand nine hundred and thirty-three (7,933) tires collected since December 2018. Upcoming event the first Saturday of May. City of Willows event scheduled for May18, 2019.

Beverage Container Recycling City/County Payment Program

Fiscal Year 2018-19 program application approved for payment of twenty thousand dollars (\$20,000.00). Cities of Willows and Orland are participating. Highway litter clean-ups through County have collected 10.5 tons of litter and recycling.

Mattress Recycling Council

County Counsel in review process of contract to create a permanent recycling facility at the landfill. This allows residents to drop off mattresses free of charge. Mattress Recycling Council for accepting, storing, and handling of mattresses compensates the landfill.

Community Clean-Up Events

None planned at this time.

Chair Barr expressed his gratitude and praised Public Works for their cleanup efforts.

Dr. Qureshi shared that we use Valley View and our Landfill Staff for roadside clean-ups.
