1. DWR update

Erin Smith provided an update on the fall groundwater conditions throughout the Northern Sacramento Valley, with an emphasis on conditions in Glenn County. Ms. Smith reviewed the current precipitation (Sacramento Valley-8 station index) and NOAA's precipitation forecast. Ms. Smith also reviewed fall 2015 groundwater levels and change maps comparing 2004 to 2015, 2011 to 2015, and 2014 to 2015 focusing on the 100-450 foot depths. An overview of the wells with depths greater than 600 feet was also presented. Hydrographs were also reviewed. In addition to groundwater conditions, Ms. Smith provided a follow up discussion regarding subsidence from the November 2015 meeting.

2. Reports

- **a)** Education/Outreach Committee—The committee has not met since the last WAC meeting and has nothing to report.
- **b) Legislation Committee**—The committee has not met since the last WAC meeting and has nothing to report.
- c) TAC—The committee has not met since the last WAC meeting and has nothing to report.

3. Summer 2015 Water Quality update

Lisa Hunter reviewed the 2015 water quality handouts provided in the agenda packet. Seventeen wells were sampled during the summer. All wells were within the normal range for pH. Two wells exceeded the 700 $\mu s/cm$ agricultural standards. One of the two wells also exceeded the 900 $\mu s/cm$ drinking water standards. A summary sheet was provided that includes the 2015 measurements, the average over the period of record for each well, and the range of measurements for each well.

4. BMO revision process

An ad hoc subcommittee was created to develop policy options to be discussed during later WAC meetings. The ad hoc committee will report at the next WAC meeting as to the progress being made and potential options developed. The committee is composed of Ken Sullivan, Larry Domenighini, Rob Vlach, and Bruce Roundy.

5. Sustainable Groundwater Management Act

Lisa Hunter advised the committee that the scope of work for the facilitation services through DWR to aid in governance formation for the geographic area of the county has been approved by the Board of Supervisors and DWR. Work for that project should begin shortly. Ms. Hunter encouraged all parties, especially those representing a GSA eligible entity, to participate in this process. It was requested that a final copy of the scope of work be sent to the WAC members.

Lisa Hunter also advised that the County has submitted an application for the Counties with Stressed Basins Grant through DWR. The application is requesting funding in order to create a data management system, a hydrogeologic conceptual model, evaluation of current groundwater models, and selection of a groundwater model. The work presented in the application is consistent with the Action Plan developed by the WAC and approved by the Board of Supervisors. It is also intended to further SGMA activities.

Some discussion took place regarding the WAC's role in SGMA. Some feel that the County should only be responsible to fill in where no other entity is qualified, or an entity is unable or unwilling to become a GSA. There was also some discussion regarding the BMO process in relation to SGMA activities.

6. Election of Officers for the 2016-2017 term

Rob Vlach reported that the nomination committee met to discuss nomination recommendations. The committee recommends Rob Vlach as WAC Chairman and Darin Titus as Vice Chairman for the 2016/2017 term.

Ted Trimble provided a motion to approve the recommendation as presented. Bruce Roundy seconded the motion. It was unanimously approved to elect Rob Vlach as WAC Chairman and Darin Titus as Vice Chairman for the 2016/2017 term.
