II. PUBLIC COMMENT:

Barbara Hennigan spoke of the lower tuscan aquifer, SGMA and her desire to have coordination between counties, and surface water and groundwater interaction. Sharron Ellis spoke of her two domestic wells' conditions, and of her concern of groundwater conditions.

III. APPROVAL OF MINUTES:

The minutes of the November 13, 2014 and December 15, 2014 meetings were approved unanimously.

IV. DISCUSSION AND/OR ACTION ITEMS:

- **a.** WAC report—Larry Domenighini provided an update on WAC activities. The WAC last met June 9. Topics included a TAC update on BMO revisions, the education and outreach meetings held in February and March, the legislation ad hoc committee status, and a briefing provided to the Board of Supervisors regarding SGMA. Member reports also included drought updates. The next meeting is scheduled for November 10.
- **b.** BMO Revisions—Lisa Hunter provided an update on the BMO ad hoc committee's proposed process for BMO revisions. The well depth distribution graph was reviewed as well as the memo included in the agenda packet, the handout describing the proposed process, and examples of the proposed BMO process. Ultimately, the TAC directed the BMO committee to continue work on the BMO revisions following this same process, and to bring back to the next meeting, a map depicting a visual representation of the 50% wells at risk mark within ten years.
- **c.** Review process for and potential updates to the Abnormal Groundwater Level Reports—This item was not discussed and will be brought to a later meeting.
- **d.** Other topics of interest
 - 1. Sustainable Groundwater Management Act updates—A list and map of agencies that have applied to become a Groundwater Sustainability Agency is included in the agenda packet. It is currently unknown how the area will resolve overlapping issues. Discussions will be taking place.
